**REQUEST AND ORDER DEFERRING FURTHER PROCEEDINGS  
PENDING COMPLETION OF DRIVERS SAFETY COURSE  
(Not Valid Until Signed by the Defendant and the Court)**

YOU MUST COMPLETE YOUR DRIVING SAFETY COURSE AND SUBMIT YOUR DRIVING SAFETY COURSE CERTIFICATE **AND** DRIVING RECORD TO THE COURT ON OR BEFORE \_\_\_\_\_.

By my signature below I, the above names defendant plead **No Contest** to the above-referenced case, waive a jury trial and elect deferred disposition pending completion of the Driver's Safety Course. I agree to the following conditions:

1. I understand that I must show proof of financial responsibility and a valid Texas driver's license with my request to take a driving safety course.
2. I have not taken a driving safety course to have a citation dismissed in any court in Texas during the last one (1) year immediately proceeding the date of the alleged offense.
3. I am not currently in the process of taking a driving safety course, nor have I completed a driving safety course to have a citation dismissed that is not yet reflected on my driving record.
4. I understand that I have ninety (90) calendar days (see completion date given above) from the effective date to complete a State-approved driving safety course and that **NO EXTENSIONS WILL BE GRANTED.**
5. I understand that I am responsible for requesting a certified copy of my driving record from the Department of Public Safety in Austin, Texas. **NOTE: THIS SHOULD BE ORDERED IMMEDIATELY. YOU DO NOT NEED TO HAVE YOUR DRIVING RECORD BEFORE YOU TAKE THE DRIVING SAFETY COURSE.**
6. I am responsible for returning to this court the Court copy of the certificate of completion showing that I have completed the driving safety course within ninety (90) calendar days from the effective date of this Order, along with a certified copy of my driving record. I hereby promise to return such proof to the Court no later than ninety (90) days from today's date. **I UNDERSTAND THAT THE TICKET CANNOT BE DISMISSED WITHOUT BOTH THE CERTIFICATE OF COMPLETION AND MY DRIVING RECORD WHICH SHOWS MY ELIGIBILITY TO TAKE THE COURSE BEING FILED WITH THE COURT.)**
7. I understand that when I have completed the driving safety course and have returned the required proof, the Court will dismiss my traffic citation and that a record of attendance will appear on my driving record. I understand that the driving school will charge a fee for the course and in addition, I must pay an administrative fee of **\$112.00 (\$137.00 if in school zone)** which must be submitted to the Court with this Request.
8. I understand that non-compliance of any of the above conditions may result in the Court's issuing a warrant for my arrest and a fine becoming due and payable to the Court. I understand **\$10.00** of the fee is non-refundable and that I will not receive refund or credit. **FAILURE** to comply shall cause this case to result in a **CONVICTION**, payment of a **FINE of \$200.00** plus costs and the conviction will be reported as required by law.
