1. Approve minutes.
2. Financial and bookkeeping matters, including payment of bills and review of investments.
3. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
4. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
5. Authorize renewal of District's insurance policies, including review of engineer's list of District facilities to be insured.
6. Engineering matters, including:
  - a. design of construction projects in the District;
  - b. approve plans and specifications and authorize advertisement for bids for construction projects in the District;
  - c. review bids and award contract for construction of projects in the District;
    - i. Cottonwood, Section 3B;
  - d. approve pay estimate, change order, and final acceptance and direct engineer to notify insurance company of acceptance as appropriate, for construction projects in the District, including:
    - i. water, sewer, and drainage facilities for Cottonwood Section 3A; and
  - e. deeds and/or easements.
7. Report regarding development in the District.
8. 2014 Directors Election, including:
  - a. approve and distribute Certificates of Election; and
  - b. approve Directors' Sworn Statements, Bonds and Oaths of Office.
9. Reorganize Board and elect officers.
10. Authorize filing of District Registration Form with Texas Commission on Environmental Quality.


