FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 167

The Board of Directors of Fort Bend County Municipal Utility District No. 167 will hold a regular meeting on Thursday, March 3, 2016, at 12:00 p.m., at the offices of Si Environmental, 6420 Reading Road, Rosenberg, Texas, to discuss and, if appropriate, act upon the following items:

2. Approve developer reimbursement report for Series 2016 Bonds and authorize disbursement of bond proceeds.
3. Financial and bookkeeping matters, including payment of bills and review of investments.
4. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
5. Adopt Resolution Concerning Exemptions from Taxation.
6. Authorize delinquent tax attorney to proceed with collection of personal property tax.
7. Storm water pump station operating matters, including proposals for repairs and maintenance.

 - iii. water, sewer, and drainage facilities to serve The Reserve at Brazos Town Center, Section 5; and
 - iv. water, sewer, and drainage facilities to serve The Townhomes at Brazos Town Center.
 - d. deeds, easements, Phase I Environmental Site Assessment proposals, execution of plats, consents to encroachment, requests for service, and utility commitment letters; and
 - e. Utility Conveyance and Security Agreements with the City of Rosenberg.
12. Park and recreational facility matters, including:
 - a. approve plans and specifications and authorize advertisement for bids for construction of District facilities;
 - b. review bids and award contract for construction projects in the District;
 - c. approve pay estimate, change order, and final acceptance and authorize engineer to notify insurance company of new facility, including Brazos Town Center, Section 3, Landscape Improvements; and
 - d. park plan for new sections.


