All bids must be submitted at the time and place in the manner prescribed above. Bids must be delivered in a sealed envelope with a return address and clearly marked "**CITY OF ROSENBERG, BID NUMBER 2018-02, BAKER ROAD AND CUMINGS ROAD PAVING REHAB, FORT BEND COUNTY, TEXAS**". The bidder's firm name shall appear on the outside of the envelope. Bids received after the closing time will be returned unopened.

This is an acknowledgement that Federal Emergency Management Agency (FEMA) financial assistance, Public Assistance fund requirements apply to this contract. The awarded Contractor will comply with all applicable federal laws, regulations, executive orders, FEMA policies, procedures, and directives; and any and all other governmental agency regulations with jurisdiction over response and recovery actions. The Federal Government is not a party to the awarded contract and is not subject to any obligations or liabilities to the non-Federal entity, Contractor, or any other party pertaining to any matter resulting from the contract. The Contractor acknowledges that 31 U.S.C. chap. 38 (Administrative Remedies for False Claims and Statements) applies to the contractor's actions pertaining to this contract.

Pursuant to Texas Government Code 2252.908, the successful bidder must be able to provide The City of Rosenberg with a printed and executed original of a completed Certificate of Interested Parties form (Form 1295) with the signed contract. Failure to do so will result in the City's inability to execute the contract. If the amount of the bid exceeds \$50,000.00, Official Bidder's Bond signed by the Surety and Bidder, Cashier's Check, Certified Check, or letter of credit from a FDIC insured bank in an amount equal to five percent (5%) of the total bid must accompany each proposal.

A Mandatory Pre-bid Conference will be held on **Wednesday, January 24, 2018 at 11:00 a.m. in the City Hall Council Chamber, at 2110 4th Street, Rosenberg, Texas.** Attendance at the conference is mandatory, and bids will be accepted from only those Contractors attending. Any bids received from Contractors not in attendance will be returned unopened. The Engineer will determine the validity of attendance, at the Engineer's sole discretion.

The City reserves the right to reject any or all bids and to waive informalities in bidding. In case of ambiguity or lack of clearness in stating the prices in any bid, the City reserves the right to consider the most advantageous construction thereof, or to reject the bid. The award will be made to the responsible bidder submitting the lowest bid as determined by the City, or to the bidder who provides goods and services at the best value to the City.

Bids may be held by the City of Rosenberg for a period not to exceed sixty (60) days from the date of the bid opening for the purpose of reviewing the bids and investigating the bidders qualifications prior to the contract award. The City of Rosenberg is an Affirmative Action/Equal Opportunity Employer. Minority Business Enterprises, Small Business Enterprises, Women Business Enterprises, and labor surplus area firms are encouraged to submit.
